This is the only letter you will receive this year regarding the horse department requirements. State Fair Qualification: There will be no qualifying show. The first 850 people to sign up will be able to go. Reminder when signing up that you and your horse should be ready to compete at this level. Full control is needed at all gaits so as not to interfere with another riders ride. You will also be required to submit additional paperwork noting classes to the Extension Office after you register as well as a negative coggins test dated after January 1, 2020 to be eligible to exhibit at the OSF.

State 4-H Horse Rule: All horse members must have an approved helmet during a 4-H event.

Horse Camp...Due to the COVID-19 there will not be a camp this year. Possibly clinics when restrictions are lifted.

Horse Skill-a-thon will be held on Tuesday of the fair in Rhonemus Hall.

***Horse Quality Assurance: For 2020 ALL Horse Exhibitors will need to complete Horse Safety and Ethics (Horse QA). You will watch two videos and complete a short quiz. This must be completed by August 1st for Brown County Junior Fair exhibition and July 1st for State Fair exhibition.

Fair Class Sign ups and clean up the barn day will be Monday, September 14th, 6:00 p.m. to 8:00 p.m. Pending guidance from COVID-19. Bring sponges/rags, buckets, broom, Clorox/cleaners and gloves. Members will need to attend one of the cleanup days to participate in the fair. We are once again offering to have your stall cleaned for \$10 per stall and is to be paid on September 9th. It is highly encouraged that you stall in the Junior Fair Horse Barn for free.

Reminder: Horseless Horse judging is September 9, 2020, 6:00 p.m. during general project judging.

Equine Ambassador: Applications for Industry Ambassadors are due August 1st. Youth interested in applying must be 15 years of age or older as of January 1 of current year. Application information can be found at http://brown.osu.edu/awards

**Chris Balz nominees: turned in by September 1 by a 4-H advisor to the OSU Extension Office. Voting times will be Tuesday of fair from 12:30 p.m. to 3:30 p.m. and Wednesday of fair from 9:00 a.m. to 12:00 p.m. at the OSU Extension Office (on the fairgrounds).

HORSE EXHIBITOR BARN MEETING - will be held Sunday of fair at 2:00 p.m. This is mandatory or all exhibitors.

Body Score Requirements: A horse brought to fair should be in a Body Condition Score of 4 to 7 by clean up days. The Body Score Condition Packet can be found at https://brown.osu.edu/exhibitorletters. You should review this at least 60 days prior fair. The current picture turned in for review at the June 1 deadline will be reviewed and if you are out of the 4 to 7 scope you will be asked to turn in another picture by clean up days.
